

BULLETIN OF PROFIT RATES FOR DEPOSITS

UNITED BANK OF ALBANIA informs you that, starting from 03.06.2026, the planned profit rate of the deposits will be calculated according to the following condition:

In cases when the bank no longer offers a deposit product with the same term and interest rate as the one specified in the contract, a deposit will be selected that is a close as possible to the term and interest rate of the existing contract, based on the bank's current products.

Note: The above profit rates may vary depending on the investment

The profit of every deposit product in the bulletin will be received at the end of the maturity. In the case of early closing, profit is not obtained.
